### Board Member Fundraising Duties

All board members shall actively participate in fundraising.

Members shall identify and evaluate prospects, cultivate and solicit gifts, and actively support programs with their presence. Members shall also offer personal acknowledgments (thank you's) to donors and volunteers.

Board members must contribute financially, at a level considered personally generous, and agree to make Habitat one of your top three gifts, at least once per year.

## **Board Member Responsibilities**

Attend and participate in board meetings; review minutes and materials before meetings and come prepared.

Attend organization's events and support fundraising activities.

Understand the legal aspects of board membership, fiduciary responsibilities, ethics of a nonprofit organization, loyalty, conflict of interest, and confidentiality.

Act in the best interests of the organization and excuse myself from discussion and votes where I have a conflict of interest.

Describe the organization's work and values to the community, represent the organization and act a spokesperson.

Contribute financially and advocate in the community with donors for private contributions

Join committees and serve/donate time in addition to board meetings.

Participate in strategic and long-range planning.

Participate in ongoing Board of Director's training and retreats.

Communicate promptly with the ED and/or the Board Chair if there are problems, questions, etc.

## **Board of Directors Member Agreement**

Members of the Board of Directors for Habitat for Humanity of Summit & Wasatch Counties have a legal and moral responsibility to ensure the organization does the best work possible in pursuit of its goals. Directors must believe in the purpose and the mission of the organization and act responsibly and prudently as its stewards. As such, each member of the Board of Directors will be asked to affirm the following upon election to the Board.

**1.** Describe the organization's work and values to the community, represent the organization and act as a spokesperson.

2. Join and serve on at least one Board or Operating Committee for the organization.

- 3. Attend at least 80% of regular board meetings and committee meetings.
- 4. Make a personal financial contribution at a level that is meaningful to them.
- 5. Actively participate in fundraising activities and special events.

6. Act in the best interests of the organization and excuse themselves from discussion and votes where they have a conflict of interest.

7. Take the initiative to stay informed about what is going on in the organization. Ask questions and request information. Participate in and take responsibility for making decisions on issues, policies, and other board matters.

8. Work in good faith with staff and other board members as partners toward achievement of our goals and be respectful of the staffing structure in place.

9. Support fellow board members, value their opinions, and stay open-minded and flexible.

10. Expect the Board Chair or ED to call and discuss the responsibilities if these commitments to the organization are not being fulfilled.

**11.** Understand that this position is for a course of four years from the annual meeting on or immediately following an election to the Board.

12. Understand that Directors may run for re-election for a second term and for a total of eight years on the board.
